



Application to extend the time limit to submit the Basis of Claim Form

Use this form to request extra time to submit your Basis of Claim (BOC) Form to the Refugee Protection Division (RPD).

Important information

- Submit this form to the RPD at least three (3) working days before your BOC Form due date.
- If the RPD accepts your application, the RPD will notify you of the new due date for your BOC Form.
 If the RPD does not accept your application, you must provide your completed BOC Form by the original due date.
- If you do not provide your completed BOC Form on time, and you do not apply for extra time, then the RPD will hold a special hearing called an abandonment hearing. If the RPD decides that your claim has been abandoned, your claim will not be heard, and you will not be allowed to make another refugee protection claim in the future. You may be required to leave Canada.
- You can contact Registry if you do not know your BOC Form due date or the date of your abandonment hearing.
